The application must include the following documents and information. In order to avoid prejudicial errors to both parties, you must provide all required documents. Failure to comply may result in the delay or rejection of the request.

- 1) Proof that the applicant is the owner of the lot, if the applicant has acquired this lot within a period of less than one year:
- 2) Proxy signed by the owner allowing the applicant to request a permit on his behalf;
- Plans, elevations and sketches for the work as described in No. 2013-003 relating to zoning regulations for banks;
- 4) The proposed landscape, location and nature of the work;
- 5) The reason for such works;
- 6) The location of buildings, lakes or rivers, cliffs or other, if applicable;

- 7) Existing topography and proposed grading; (lines of difference in ground at intervals of at least one (1) meter, (except docks));
- 8) Lines of land elevation and contours at intervals of (1) metre minimum (exception mark of the docks);
- 9) One or several photographs showing the actual state of the shore;
- 10) Authorization from the department of environment, if applicable:
- 11) Description of planned measures to prevent pollution, sediment erosion and transport.

## WORK OF STABILIZATION, if applicable:

- 1. One plan prepared by a qualified professional stating precisely the boundaries of the bank;
- 2. A document showing the work or works provided indicating the rehabilitation measures at the site. In the case of bank stabilization work provided by plants, the applicant must submit to the Municipality expertise prepared by a qualified professional. In the case of stabilization work provided by riprap, gabions or retaining walls, the applicant must submit to the Municipality expertise and plans prepared by an engineer and be made according specific standards set out in Article 9 law number 2013-003 relating to zoning;
- 3. The permissions required by the Ministry of Sustainable Development, Environment, Wildlife and Parks, or any other government agency, if applicable;
- 4. Readings shall be taken on the natural ground level, without backfill. If the land was filled in, the level of the fill may be used if it is demonstrated that it was made before the entry into force of the first law prohibiting new construction and embankments at this location
