The **municipal council** of the municipality of Lac-Tremblant-Nord is composed of the mayor, Mrs. Kimberly Meyer, and six councillors, Mrs. Louise Royer and Sirs Jean Cloutier, Philippe Couture, Charles de Broin, Éric Lessard and Peter Richardson.

Council meetings are held once a month at 144, du Couvent Street, Mont-Tremblant (Village) on Saturday morning at 11 am. The meeting schedule is on the website (<https://lac-tremblant-nord.qc.ca/>) under Municipal Council section. You are always invited to attend and meet your councillors, ask questions, share your ideas and interests or simply as an observer to learn about the decision-making process at the municipal level. We place a high value on the opinions we gather during our consultations with citizens.

You will find on our website all the useful information on the various activities of the council, as well as the rules governing municipal life in Lac-Tremblant-Nord. You will also be able to consult the majority of the regulations in force in the territory and you have access to the common application forms for permits and authorizations for your projects. **Do you have a project → Come meet the municipal inspector. A permit or a certificate of authorization must be obtained before starting the work.** Some applications must be submitted to the Planning Advisory Committee (PAC) and Municipal Council for approval.

The marinas in the Lac-Tremblant-Nord territory are administered by Preservation Lac Tremblant North (PLTN), a non-profit organization created and managed by volunteer members of the community whose aim is to maintain the environmental integrity of the region for future generations. Our municipality is part of to the **agglomeration of the city of Mont-Tremblant** and our residents are entitled to certain recreational privileges of the city of Mont-Tremblant. You

must obtain the Vivre Mont-Tremblant / Lac-Tremblant-Nord card to enjoy these privileges. Note that as the municipality is part of the agglomeration of the City of Mont-Tremblant, it will also send you a municipal tax bill for the services under its responsibility. <http://www.villedemont-tremblant.qc.ca/>.
